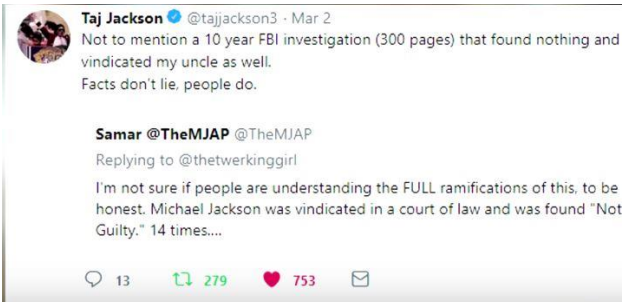

According to James Safechuck he was abused by Michael Jackson between 1988-1992. Abuse happened i.a. in a train station. The train station was built in 1994. Construction started in late 1993.

The settlement was made 25.1.1994 for neglecting Chandler (NOT from the molestation) they could still testify against him and there was still an ongoing criminal investigation about molestation claims.

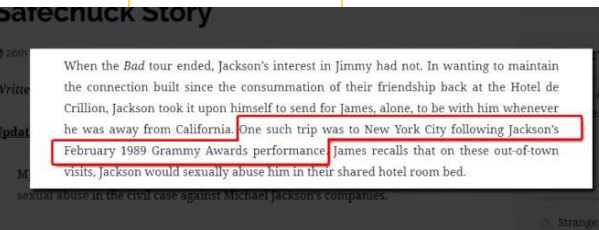

1993 Accusations of Jordan Chandler

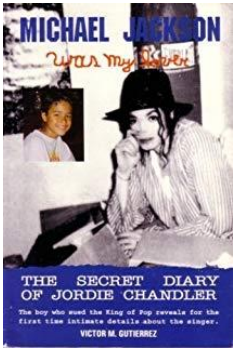
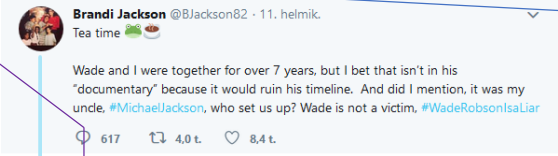
Wade Robson and Brandi Jackson are dating and introduced by MJ (around 1994-2001). It's apparently not considered relevant enough to tell at the document.

Evan Chandler admitted drugging Jordan Chandler when he said that MJ had molested him. At first he denied it, then admitted it and later denied it again.



After the Jordan Chandler accusations, a man published "a secret diary" from Jordan Chandler. MJ sued the writer and it was proven in court that Jordan didn't have a diary. There is written about "Jordan's mock wedding" just as Safechuck describes his. The diary was full of claims that Jordan Chandler had testified other way and included Brett Barnes, who till this day says MJ did nothing. But is suing HBO for the document, which hints that he and Culkin were molested.

in Japan. According to James, the first incident of sexual abuse occurred during the Paris portion of the *Bad* Tour in June 25-29, 1988.

According to James Safechuck he was sexually molested by Michael Jackson at Grammy awards in 1989 held in New York. In 1989 the Grammys were actually held in Los Angeles. In February 1988 Michael was part of the Grammys in New York, but James couldn't have just remembered the year wrong, because he has told that the first molestation happened in June 1988.

Safechuck claims that they had a wedding ceremony, where MJ gave him a ring which he still got. They also wrote wedding vows. Unfortunately he didn't keep that.

After this Safechuck claims that MJ took him to "honeymoon" to EuroDisney (Disneyland Paris) in 1989. It was established in 1992.

Evan Chandler was more than \$60,000 behind child support payments and had already approached Jackson several times asking for money. On July 8, 1993 Chandler was recorded saying, "If I go through with this, I win big time. There's no way that I lose. I've checked that out inside out...I will get everything I want, and they will be destroyed forever." In the same conversation, when asked how this would affect his son, Chandler replied: "That's irrelevant to me ... It will be a massacre if I don't get what I want. It's going to be bigger than all us put together ... This man [Jackson] is going to be humiliated beyond belief ... He will not sell one more record." Evan would claim Jordan had confessed the abuse to him on July 16.

In 1994 Jordan Chandler filed emancipation from his parents and have had no contact with his mother since 1994. In 2006, court documents filed in the state of New Jersey revealed that Evan Chandler was sued by Jordan after he nearly killed him with a barbell and mace in August 2005. Jordan obtained a permanent restraining order against his father as a result. Evan Chandler committed suicide on November 5, 2009.

Wade Robson cheated Brandi Jackson with Britney Spears (and multiple other women according to Brandi Jackson in order to advance in his career).



When Gavin came to Michael and asked if he could sleep in MJ:s room. Michaels friend Frank Cascio was there and noticed something was off. Michael decided that the kids (Gavin and another children) could sleep in his bed, but MJ and Frank would sleep on the floor. According to MJ Gavin and Michael never slept in the same bed.

The Arvizos praised Michael in 2003 and then they alleged that he molested Gavin during the same time they took part in his rebuttal video praising him lavishly for his kindness and generosity. To justify that, they alleged they were held captives and they were forced to speak highly of him, thus Then they added the charge of conspiracy and abduction. During that time they left the ranch several times and always came back to Neverland. They never went to the Police, they never told anyone they were imprisoned in Neverland. Then Janet alleged abduction to Brazil in a hot air balloon. The jury burst into laughter.

2002

2003 Accusations of Gavin Arvizo

Arvizo changed the timeline of the whole molestation-story, when MJ had an alibi at first timeline.

Chris Tucker testified that the family had tried to hustle him. There was a fundraiser for gavin and the boy told Chris they got no money (even though Chris had seen it was full of people), so Chris gave at least 1.500\$ to the boy. The family managed to also get three weeks vacation all paid and they almost convinced Chris to give them his car. Chris warned MJ about this family, when they arrived to Neverland. According to Chris the boy always used his illness for example: " "Chris, let me have this" "Let me have this. Come on, I'm not feeling great." Also, a comedian George Lopez testified given money for the Arvizo family and later on cut ties with them, as they become more demanding.

According to a friend of Michael, Mark Lester, the Arvizo family behaved poorly, broke into winecellar ,robbed wines from there and raced MJ:s golf carts by rolling them down the ranch's hills. Lester sais the Leaving Neverland document makes him sick. "I never saw or was party or even had the slightest notion that there was anything untoward with Michael. My children were for maybe seven or eight years with Michael's children, playing together. I was godfather to his children, he was godfather to my children."

Blanca Francia, a thief who was fired by MJ after getting caught and who then sued MJ for molesting his son while tickling him and who sold her story to Hard Copy for \$20 000 as a supporting witness. She claimed to have seen MJ in shower with Wade Robson. Francia and his badly acting son were destroyed on the stand when Francia had to admit that she only saw one figure in the shower and heard only one voice not two as she previously claimed and his son's testimony was so ridiculous jurors actually laughed at him.

2005 MJ was declared Not guilty for all the charges in June 14.

Wade Robson was the first witness. Why would MJ want him to be there, if he was molested. Esoecially when there were according MJ:s lawyer Thomas Mesereau a dozens of other witnesses who hadn't been molested (either).

Wade says he had dinner with whole family at Neverland ranch before the testimony and then felt sorry for Paris, and other kids who would be left without a father if MJ would go to jail and that convinced him to testify for MJ. Taj Jackson was on this dinner and it happened after the testimony. Also, Brett Barnes confirmed this as they flew together with Wade.

According to James Safechuck Michael Jackson asked James to testify for him on the trial 2005. When James refused, MJ got really angry and threatened James. In reality James was not one of the boys that judge allowed to testify. I't wasn't up to Michael or his lawyers, but the court have ruled james out already from the start. James was banned from the trial and therefore couldn't testify even if Michael or his lawyer wanted so.

Gavin Arvizos mother, Janet, had a history of perjury and fraud as well as a welfate fraud that she was convicted in 2006, a year after Michael Jackson was acquitted. She obtained government assistance she did not qualify for and previously she got a 152.000 dollar settlement from JC PENNEY , when she and her kids falsely and effortlessly accused under oath a security guard, who caught them shoplifting, of sex abuse.

According to some sources in 29.6.2009 Jordan Chandler admits Michael Jackson never molested him. THIS MIGHT BE FALSE NEWS.



After Michael Jacksons death it's not possible for the death estate to file a lawsuit on defamation.

2010

Michael Jacksons former bodyguard Bill Whitfield told in 2010 and again in 2019 that they had plenty of conversations about women and MJ asked frequently to be alone with women. According to him, he was heterosexual. Lisa Marie Presley have also talked openly about their sexual aspect of the relationship. Two other bodyguards told about these happennings also in an interview in March 2010.

In 2010, the British journalist Charles Thomson wrote an article for *The Huffington Post* in which he described the trial as "one of the most shameful episodes in journalistic history". He described the media coverage as "out of control ... the sheer amount of propaganda, bias, distortion and misinformation is almost beyond comprehension." In the same journal, Luka Neskovic wrote that the trial "displayed media at their worst. Sensationalism, exclusivity, negativity, excentricism, chaos, and hysteria were some of the features." For example, according to Neskovic, when pornography was found in Jackson's home, many media outlets misreported it as child pornography.

Wade Robson doesn't get the part to direct Michael Jackson Cirque du Soleil, which he had already told in interviews he would be directing.

Other:

- James realized he was abused May 20, 2013, still the mother danced and celebrated MJ's death already in 2009. James told he had never told anyone about the abuse before that date.
- Document tries to show that MJ was the one who started the relationship with the boys and their families, while it's been documented that for example after their first mee, over the next two years Wades mother sent videos and letters to MJ about Wades progress as dancer, but never heard from MJ. Finally the family went to a shooting in 1990, where they reconnected.
- Aren't after the money, but justice. Still, wants a lot of it as been seen. According to Statute of limitations they should have made the accusations within two years after they turned eighteen. There's still a loop hole if they didn't understand being molested until later. They claim to have just realized it before making their first molestation charges. You can hear them being very careful how they plan their words in all the interviews now.

2013 Accusations of Wade Robson

Robson seeks for 1,5billion from estate. Wade robson released his story right after the seven years of statue of limitations. He can't be charged for perjury.

Combined till the day (03/2019) Wade Robson has already had two lawsuit been dismissed and James Safechuck one. Now they have put one together and hope the document would help in getting "justice".

2014 Accusations of James Safechuck

According to the document Wade Robson was left alone in the Neverland Ranch with Michael in 1990, when his whole family went to see Grand Canyon for five days. In 1993 Joy Robson testified that Wade hadn't been alone at Neverland until 1993. Also in 2016 she confirmed that the whole family including Wade went to Grand Canyon.

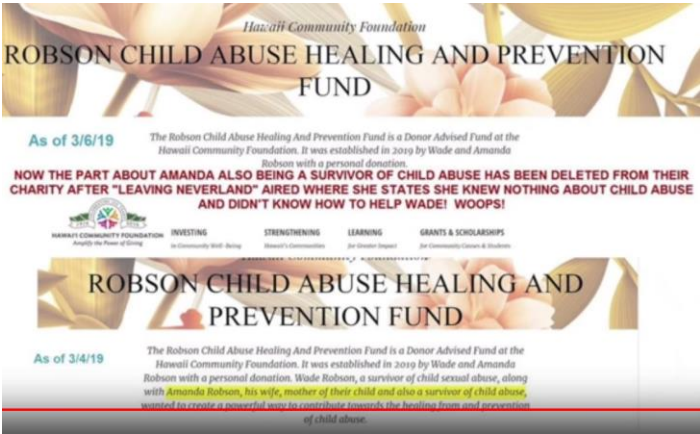
In 2017, the documentary series *The Jury Speaks* covered the trial with four members of the jury. Some reported receiving anonymous threats, and one said someone had loosened the wheels on her car. All said they would acquit Jackson again, even in the wake of later allegations. One juror said: "It was pretty obvious that there were ulterior motives on behalf of the family ... there wasn't a shred of evidence that was able to show us or give us any doubt in voting guilty.
